REGISTRATION POLICY 2025-26

- Registration form must be completed (2 sides) and signed by parent/guardian.
- Registration form must be accompanied by a non-refundable registration fee of \$120* plus tuition for May 2026. This tuition is due at time of registration for all children (daycare parents, please see below) and is also non-refundable. If your child remains in school throughout the year, the tuition is applied toward the last month's (May) payment. Otherwise, this tuition is forfeited.
- We expect 3 ¹/₂ year old children to be potty trained.
- ♦ Hours for the kindergarten/preschool are 9:00 a.m. 12 noon. Carpool begins at 8:50 a.m. each morning and 11:50 a.m. for pick-up. Lunch bunch for non-daycare is available until 3 p.m. but requires a reservation. (*Call the office to make a reservation for lunch bunch.*) Lunch and play is the same as lunch bunch except that you pay for it regardless of whether you are here or not, and you do not need to make a reservation. Space is limited for Lunch & Play. Early drop off is available from 7:00 a.m. until 8:50 a.m. for our preschoolers. For details, please refer to the God's House Handbook.
- Daycare is open from 7:00 a.m. until 6:00 p.m.
- A current certificate of immunization from your child's pediatrician must be received in our office by the first day of school.

ATTENTION DAYCARE PARENTS!

Those parents registering a daycare child for June 2, 2025 will be required to pay advanced tuition of \$400 as well as a 120^* registration fee. This advanced tuition will be applied toward the next year's May tuition, if your child is at God's House. **These amounts are non-refundable.** Our daycare program runs from June 2 – May 29.

*Registration fee: 1st child - \$120; 2nd child - \$60; 3rd child - \$30.
